NOTICE OF PUBLIC HEARING

For the purpose of Section 147(f) of the Internal Revenue Code of 1986, as amended, notice is hereby given that the Exambia County Housing Finance Authority (in Card on behalf of the Board of County Commissioners of Exambia County, Floride, will hold a public hearing at 10:30 a.m. on March 27, 20:23, in the conference room of the Authority located at 700 South Palafox Street, Suite 310, Pensecola, Florida 32502, to consider a plan of finance for the issuance of bonds for the following purpose:

The Authority proposes to issue not exceeding \$26,000,000 in aggregate principal amount of its revenue bonds (the "Bonds"), in one or more installments or series and bean the proceeds of such Bonds to The Moorings Affordable LLC, a Horida limited liability company or its affiliate (the "Bocrower") for the purpose of financing or refinancing the costs of acquiring, upgrading, reconditioning, rehabilitating, improving and beautification by the Borrower of an existing multifamily rental housing facility presently containing approximately 200 units known as The Moorings and located at 891 Old Spanish Iral, Pensacola, Florida 2514 (the "Project"), to provide rental housing facilities for persons of Illus uses flow middle and moderate process. The Posicient will be nowed the and moderate process. low, very low, middle, and moderate income. The Project will be owned and operated by the Borrower

The Bonds, when issued, will be special, limited obligations of the Authority payable solely out of the revenues derived from a financing agreement with the Borrower. The Bonds and interest thereon shall never pledge the taxing over, or constitute the debt or indebtedness of the Authority, Escambia Cour ty, Florida, the State or any other political subdivision, public agency or munici-pality thereof within the meaning of any constitutional or statutory prohibition. The Authority has no taxing power.

At the time and place fixed for said public hearing all who appear will be given an opportunity to express their views for or against the proposal to approve said Bonds and the plan of finance, including the Project Isted above. Prior to said public hearing, written comments may be delivered to the Executive Direc-tor of the Authority at 700 South Palafox Street, Suite 310, Penascola, Florida 32502. All persons are advised that, if they decide to appeal any decision made 350V. An persons are advised that, it may decode to appeal any decision made by the Authority with respect to any matter considered at this meeting, they will need a record of the proceedings, and for such purpose, they may need to ensure that a verbalim record of the proceedings is made, which record in-cludes the testimory and evidence upon which the appeal is to be based. All in-terested persons are invited to present their comments at the time and place set forth above.

The Authority will thereafter submit its public hearing report concerning this public hearing to the Board of County Commissioners, Exambia County, Florida, for issuer approval as the applicable elected representative for the issuance of the Bonds.
